# 2 Migrate web services from ARIS version 7.2 to ARIS version 9.x

Web services used in ARIS version 7.2 can be migrated for further usage in ARIS 10.0.

Web services serve as a universal system for communication between applications and services. By specifying the interactions and sequence of Web services, integrated,

service-oriented systems that can reflect and process business management requirements on the basis of company processes are created from the basic modules of Web services.

Both ARIS 7.2 and an ARIS 10.0 must be installed.

A CentraSite server must be installed because CentraSite is used as a repository for the web services.

You first have to export the services from ARIS version 7.2 (page 3), then, you have to import the web services into CentraSite (page 5).

After that, you have to import the services to ARIS 10.0.

#### 3 Exporting web service out of ARIS 7.2

Export the web services from ARIS 7.2 and save them as WSDL files.

#### 3.1 Exporting web services out of ARIS

Export software services as an XML-based WSDL file.

Procedure

- 1. Select a software service, a model that contains the software service, or a group in which the software service you want to export is saved.
- 2. Select File > Export > Service description.
- 3. The dialog for exporting the service opens. Define the relevant settings and click **OK**.

The web service is exported to a WSDL file. Any related data - for example XML schemas - is also exported.

#### 3.2 Exporting an XML schema out of ARIS

Export an XML schema definition as an XML-based file.

Procedure

- 1. Select an XML schema definition or the group that contains the XML schema definition you want to export.
- 2. Select **File > Export > Data structures**. The dialog for exporting an XML schema opens. Define the relevant settings and click **OK**.

The XML schema is exported to an XSD file.

#### 4 Importing services into CentraSite

Import the WSDL file based services to your CentraSite server.

#### 4.1 Importing a web service to CentraSite

You can import one or more web services from a web server or a file system to a CentraSite registry and repository. For the import, you must specify a WSDL file that may define one or more web services.

You can update web services in CentraSite by importing an updated WSDL file. The WSDL file must have the same namespace, service names, and organization as the original WSDL file. It may also include additional web services. However, it is not possible to remove a service from CentraSite via an updated WSDL file that no longer includes the corresponding service element.

Please note that the import will fail if you specify a WSDL file containing a namespace and services that already exist in CentraSite but are affiliated to a different organization.

#### Procedure

- 1. Start CentraSite and log in.
- 2. Click Create Asset.
- 3. Select **Service** from the **Type** list.
  - a. Optional: Enter a name.
  - b. Optional: Select the organization to which the web services are to be assigned.
  - c. Optional: Specify a version identifier for the new service. The version identifier you enter here is the service's public, user-assigned version identifier. You can enter any string in the Initial version field, that is, the version identifier does not need to be numeric. You can also leave this field blank.
  - d. Optional: Enter a Description.
- 4. Enable File in the Import a File section.
- 5. Click Choose.
- 6. Select the WSDL file you want to import.
- 7. Click Next.

In case you imported a new web service, CentraSite retrieves the specified file and creates the web service.

If the importer detects that the service you are trying to import already exists within CentraSite, the import dialog will prompt you to specify whether you want to **Create asset**, **Always overwrite** or **Always create new versions** and click **Next**.

The following registry objects and folders and files are created by the import of web services:

 In the registry, objects are created for different elements defined in the WSDL file being imported: An object of the service type is created for each **Service** element defined in the WSDL file. The corresponding name attribute in the WSDL file determines the registry object's name. The **Service** objects are assigned to the organization which you specify in the import parameters. A corresponding **Organization** object is created, if required. Depending on the WSDL file, additional objects of the following types may be created: **ServiceBinding** objects for service bindings, **SpecificationLink** objects for specification links, **Concept** objects for bindings, **Operation** objects for operations, **Interface** objects for interfaces, **BPELPartnerLinkType** objects for partnerLinkType elements in the WSDL file, **BPELRole** objects for role elements within partnerLinkType elements. The new objects are connected by associations and implicit references as required.

- For each imported web service, an external link is created, which points to the WSDL file in the repository.
- The WSDL file is copied to a subfolder of **projects/WSDL** in the repository.

The name of the subfolder is determined by the namespace defined in the **targetNamespace** attribute of the WSDL's definition element. For example, if the namespace is **http://www.MyOrganization.com/products**, the WSDL file is copied to **projects/WSDL/www.MyOrganization.com/products**.

The name of the WSDL file in the repository is built as follows:

organization\_service\_file.wsdl, where organization is the organization name you specify in the import parameters, service is the name of the service as specified in the WSDL, and file is the file name or final part of the URL specified in the import parameters. For example, when you import a web service from C:\services\MyService.wsdl, the service name in the WSDL file is queryService, and the specified organization is MyOrg, the resulting file name in the repository is MyOrg\_queryService\_MyService.wsdl.

If the WSDL file contains references to schema files, these are also imported, including all
of the schema files that are referenced. The folders and files and registry objects that are
created correspond to importing an XML schema.

#### 4.2 Importing an XML schema to CentraSite

You can import an XML schema from a Web server or a file system to a CentraSite registry and repository.

Procedure

- 1. Start CentraSite and log in.
- 2. Click Create Asset.
- 3. Select XML schema from the Type list.
  - a. Optional: Enter a name.
  - b. Optional: Select the organization to which the web services are to be assigned.
  - c. Optional: Specify a version identifier for the new service. The version identifier you enter here is the service's public, user-assigned version identifier. You can enter any string in the Initial version field, that is, the version identifier does not need to be numeric. You can also leave this field blank.
  - d. Optional: Enter a Description.
- 4. Enable File in the Import a File section.
- 5. Click Choose.
- 6. Select the XML schema file you want to import.
- 7. Click Next.
- 8. Click Save.

CentraSite retrieves the specified file and creates the XML schema.

If the importer detects that the schema you are trying to import already exists within CentraSite, the import dialog will prompt you to specify whether you want to **Always create new versions** or **Always overwrite**.

The following folders and files and registry objects are created by the import of an XML schema:

- The schema file is copied to a subfolder of projects/WSDL in the repository. The name of the subfolder is determined by the namespace defined in the schema. For example, if the namespace is http://www.MyOrganization.com/MySchemas/schema1, the schema is copied to projects/WSDL/www.MyOrganization.com/MySchemas/schema1.
- If the schema file contains references to other schema files, these are also imported, including all the schema files that are referenced.
- For each imported schema file, a registry object of the XML Schema type is created. An external link is created for the object that points to the schema file in the repository.
   When you delete an external link in the registry that points to a schema file in the repository, the schema file in the repository is also deleted. However, any schema entries in the registry and repository that are referenced by the schema being deleted remain untouched.

#### 7.3 Disclaimer

ARIS products are intended and developed for use by persons. Automated processes, such as the generation of content and the import of objects/artifacts via interfaces, can lead to an outsized amount of data, and their execution may exceed processing capacities and physical limits. For example, processing capacities are exceeded if models and diagrams transcend the size of the modeling area or an extremely high number of processing operations is started simultaneously. Physical limits may be exceeded if the memory available is not sufficient for the execution of operations or the storage of data.

Proper operation of ARIS products requires the availability of a reliable and fast network connection. Networks with insufficient response time will reduce system performance and may cause timeouts.

If ARIS products are used in a virtual environment, sufficient resources must be available there in order to avoid the risk of overbooking.

The system was tested using scenarios that included 100,000 groups (folders), 100,000 users, and 1,000,000 modeling artifacts. It supports a modeling area of 25 square meters.

If projects or repositories are larger than the maximum size allowed, a powerful functionality is available to break them down into smaller, more manageable parts.

Some restrictions may apply when working with process administration, ARIS Administration, ARIS document storage, and ARIS Process Board, and when generating executable processes. Process Governance has been tested and approved for 1000 parallel process instances. However, the number may vary depending on process complexity, for example, if custom reports are integrated.
