4 Relevant applications and components

The following ARIS software is required to use ARIS Accelerators for GDPR:

- **ARIS Architect**

With the ARIS GDPR method enhancement you identify data, systems, and processes relevant to GDPR, then you describe them according to the GDPR requirements.

Furthermore, you use ARIS Architect to configure ARIS Risk & Compliance Manager for the relevant surveys and risk assessments and you run analysis reports.

- **ARIS Connect**

With ARIS Connect business owners capture processing activities, including related data, systems, and legal entities. Compliance managers prepare surveys for the documentation or qualification of processing activities and risk assessments. Additionally, they monitor the entire GDPR implementation process and the issues for improvements using ARIS Aware dashboards.

- **ARIS Risk & Compliance Manager**

In ARIS Risk & Compliance Manager you manage surveys, risk assessments, and issues for improvements. You also capture and monitor incidents. These GRC workflows are audit-secure and include segregation of duties. ARIS Risk & Compliance Manager is integrated in ARIS Architect and ARIS Connect.

The components of ARIS Accelerators for GDPR are preconfigured for a generic use. You can adapt and enhance them to an individual GDPR solution that meets your company-specific requirements. You can customize all components in accordance with the following technical restrictions:

- Do not change the API names of ARIS Method enhancements.
- Keep to the conventions. The corresponding references can be found in the descriptions. Especially ARIS Risk & Compliance Manager requires extensive knowledge.
- Back up your customized data carefully to make sure it is not overwritten by an update.

8 Create inventories and describe assets

The documentation of processing activities (page 44) and their relationships to processes, data, systems, as well as controller (page 43) and processor (page 44) entities is a key element of any GDPR project.

Prerequisites

- You have the required license privileges and function privileges to use ARIS Architect or ARIS Connect. For detailed information, refer to the ARIS Administration online help and the ARIS Architect online help.
- ARIS GDPR method enhancement filter is imported. For detailed information, refer to the **ARIS Accelerators for GDPR Installation Guide**.

Procedure

1. Prepare the respective data objects, systems, processes, and organizational units. Use objects of the types **Organizational unit**, **Cluster/data model**, **Application system type**, and **Function** to model the elements in ARIS Architect.
2. Create the necessary inventory models for the processing activities using the **Record of Processing Activities model** type, for example, for each business segment or country.
3. Specify the relevant GDPR attributes (page 9) for the objects according to your specific requirements. To do so, use the following applications:
 - **ARIS Architect**
Use ARIS Architect if the users are familiar with ARIS Architect. To use ARIS Architect for modeling, you need extensive knowledge about modeling conventions and ARIS Method, as well as the ARIS GDPR method enhancements. Processing activity inventory models (**Record of Processing Activities model** type) can only be created with ARIS Architect. For more information on modeling and managing ARIS objects and attributes, refer to ARIS online help, ARIS Method Help, and the **GDPR Conventions for ARIS Accelerators** manual.
 - **ARIS Connect**
Use ARIS Connect if the users are unfamiliar with ARIS Architect and prefer simple tables and forms for modeling and information gathering. For detailed information on editing objects in ARIS Connect, refer to ARIS Connect online help (**Which editing options are available?**).

The relevant models, objects, and attributes for GDPR are available.

8.1 Relevant GDPR attributes

The **GDPR method extension filter** enhances the standard ARIS Method with a generic set of new models, objects, and attributes. You can use the following GDPR object attributes in addition to the standard ARIS object attributes. Only rarely are all object attributes used at the same time. Depending on your GDPR approach, method, and configuration, you use an attribute that is available at different objects, for example, Data privacy score, at one of these objects only.

GDPR processing activity	Specifies whether the function is a (GDPR) processing activity.
Description	Specifies the purpose of the processing activity.
Data privacy score	Specifies a score on a predefined scale in order to qualify the data privacy of the element. Example: The score derived from the Processing Activity Qualification questionnaire.
Data sensitivity	Indicates whether the data used by this object requires special handling. Options (default values): <ul style="list-style-type: none"> ▪ Public ▪ Sensitive ▪ Very sensitive ▪ Highly sensitive ▪ Extremely sensitive

Attribute	Use
Restriction level	Specifies the level of legal usage of the data. Options (default values): <ul style="list-style-type: none"> ▪ Unrestricted data ▪ Personal data ▪ Sensitive personal data ▪ Confidential data
Data privacy score	Specifies a score on a predefined scale in order to qualify the data privacy of the element. Example: A score derived from a data qualification questionnaire or from any external enterprise architecture system.

Data sensitivity	Indicates whether the data used by this object requires special handling. Options (default values): <ul style="list-style-type: none"> ▪ Public ▪ Sensitive ▪ Very sensitive ▪ Highly sensitive ▪ Extremely sensitive
GDPR qualification score	Indicates a score on a predefined scale in order to qualify the GDPR relevant assessment of the object. Example: A score derived from any external enterprise architecture system.
GDPR risk relevance score	Indicates a score on a predefined scale in order to qualify the GDPR risk relevance of the object. Example: A score derived from any external enterprise architecture system.
Data privacy score	Specifies a score on a predefined scale in order to qualify the data privacy of the element. Example: The score derived from the Application System Qualification questionnaire.

Data protection officer	Displays the name and address of the data protection officer. Must be included in the GDPR Record of processing activities .
Data protection representative	Displays the name and address of the data protection representative. Must be included in the GDPR Record of processing activities .

is technically responsible for	Organizational unit acting as controller (page 43). (Connection between organizational unit and function.)
carries out	Organizational unit acting as processor (page 44). (Connection between organizational unit and function.)

9 Identify processing activities and related assets

GDPR processing activities can be identified and assigned to their related assets based on the inventories of processes, data, systems, controller entities, and processor entities.

- Use **Processing activity description diagram** models and objects of the types **Organizational unit**, **Cluster/data model**, **Application system type**, and **Function** to model processing activities and associated elements.
- Use the **GDPR processing activity** attribute (page 9) of a function to specify the function as a GDPR processing activity.
- Use the **Record of processing activities** factsheet in ARIS Connect to specify processing activities and the related data, systems, controller entities, and processor entities. The respective **Processing activity description diagram** is created automatically.





9.1 Specify processing activities in ARIS Architect

Use ARIS Architect to specify existing functions as processing activities if you are familiar with the modeling of objects and models in ARIS Architect. Use ARIS Connect (page 13) if you are unfamiliar with ARIS Architect.

Prerequisites

- You have the required license privileges and function privileges to use ARIS Architect or ARIS Connect. For detailed information, refer to the ARIS Administration online help and the ARIS Architect online help.
- ARIS GDPR method enhancement filter is imported. For detailed information, refer to the **ARIS Accelerators for GDPR Installation Guide**.
- The required processing activities are available in ARIS Architect.

Procedure

1. Start ARIS Architect.
2. Click **ARIS** >  **Explorer**. The **Explorer** tab opens.
3. Click  **Navigation** in the bar panel if the **Navigation** bar is not activated yet.
4. Open the relevant model.
5. Click  **Properties** in the bar panel if the **Properties** bar is not activated yet.
6. Select the function you want to specify as a processing activity.
7. Click **More attributes** in the **Properties** bar. The **Insert attributes** dialog opens.
8. Select the **GDPR processing activity** attribute in the attribute group **Governance, Risk & Compliance** > **Compliance Management** > **Data protection regulation**.
9. Click **OK**. From now on, the **GDPR processing activity** attribute is displayed in the attribute list of functions in the **Properties** bar.
10. Enable () the **GDPR processing activity** attribute.
11. Click **Close**.

Your settings are saved. The activity is specified as processing activity.

Now you can use the **Properties** bar to easily activate the **GDPR processing activity** attribute for other functions.





9.2 Specify processing activities in ARIS Connect

Use ARIS Connect to specify existing functions as processing activities (page 44) if you are unfamiliar with ARIS Architect. For detailed information on editing in ARIS Connect, refer to the online help of ARIS Connect (**Which editing options are available?**).

Prerequisites

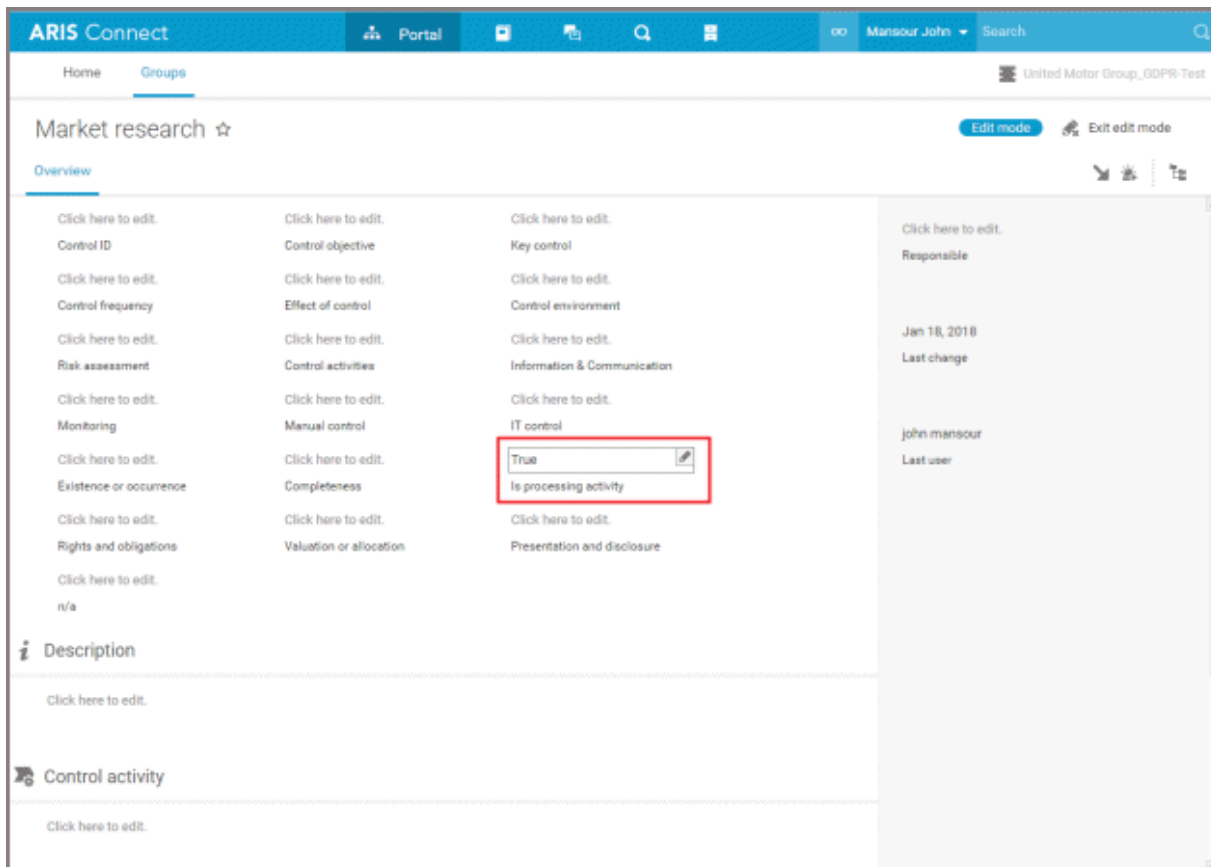
- You have the **ARIS Connect Viewer > Contribution** license privilege.
- The relevant objects are available in the ARIS database.
- The ARIS GDPR method enhancement filter is imported. For detailed information, refer to the **ARIS Accelerators for GDPR Installation Guide**.

Procedure

1. Start ARIS Connect.
2. Search for the **Activity** object (function) that you want to specify as a processing activity. To do so, enter the object name to the  **Search** field.
3. Click the relevant object in the list of results. The fact sheet is displayed.
4. Click  **Edit** >  **Contribute** if the edit mode is not activated yet.
5. Click the edit box of the **Is processing activity** attribute.
6. Select **True** and click  to transfer your input.

The activity is specified as processing activity.

9.3 Assign existing processing activities to Record of processing activities models

Use ARIS Connect to assign existing processing activities to **Record of processing activities** models.

Prerequisites

- You have the **ARIS Connect Viewer > Contribution** license privilege.
- The relevant objects are available in the ARIS database.
- ARIS GDPR method enhancement filter is imported. For detailed information, refer to the **ARIS Accelerators for GDPR Installation Guide**.
- At least one **Record of processing activities** model is available in the ARIS database.

Procedure

1. Start ARIS Connect.
2. Enter the name of the relevant **Record of processing activity** model to the  **Search** field.
3. Click the relevant model in the list of results. The fact sheet is displayed.
4. Click  **Edit** >  **Contribute** if the edit mode is not activated yet.
5. Click  **Add** above the **Processing activities** table.
6. Enter the name of the processing activity, select it from the search result, and click  to transfer your input.

The processing activity is assigned to the **Record of processing activities** model.







9.4 Create new processing activities

Use ARIS Connect to create new processing activities.

Prerequisites

- You have the **ARIS Connect Viewer > Contribution** license privilege.
- The relevant objects are available in the ARIS database.
- ARIS GDPR method enhancement filter is imported. For detailed information, refer to the **ARIS Accelerators for GDPR Installation Guide**.
- At least one **Record of processing activities** model is available in the ARIS database.

Procedure

1. Start ARIS Connect.
2. Enter the name of the relevant **Record of processing activity** model to the  **Search** field.
3. Click the relevant model in the list of results. The fact sheet is displayed.
4. Click  **Edit** >  **Contribute** if the edit mode is not activated yet.
5. Click  **Add** above the **Processing activities** table.
6. Enter a name for the new processing activity, press **Enter**, and click  to transfer your input. The processing activity is added to the **Processing activities** table.
7. Click the edit box of the **Is processing activity** attribute of the newly created processing activity.
8. Select **True** and click  to transfer your input.
9. Click the edit box of the **Description** attribute of the newly created processing activity and enter a purpose. The other attributes are specified later (page 15).

The processing activity is created and the relevant attributes are specified.

9.5 Assign relevant elements to processing activities




Use ARIS Connect to assign relevant assets to processing activities, for example, data and application systems.

Prerequisites

- You have the **ARIS Connect Viewer > Contribution** license privilege.
- The relevant objects are available in the ARIS database.
- ARIS GDPR method enhancement filter is imported. For detailed information, refer to the **ARIS Accelerators for GDPR Installation Guide**.
- At least one **Record of processing activities** model is available in the ARIS database.

Procedure

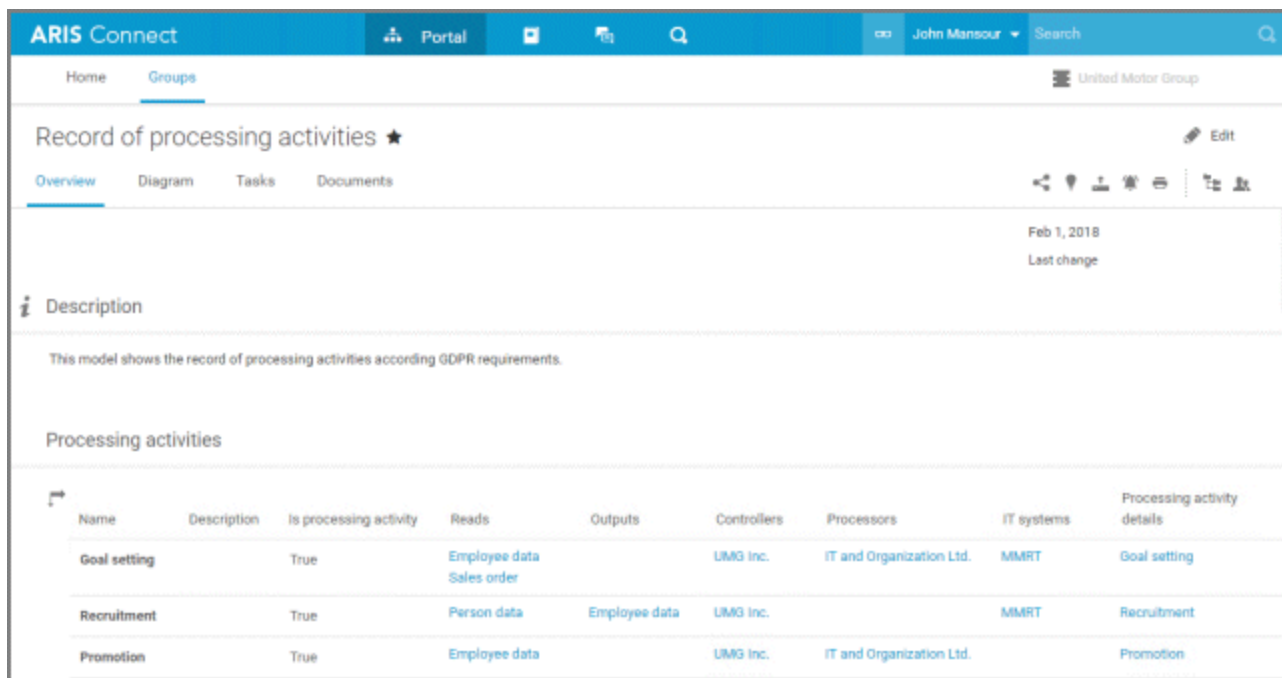
1. Start ARIS Connect.
2. Enter the name of the relevant **Record of processing activity** model to the  **Search** field.

3. Click the relevant model in the list of results. The fact sheet is displayed.
4. Click  **Edit** >  **Contribute** if the edit mode is not activated yet.
5. Assign the relevant processing activity (page 14) if it is not assigned yet.
6. In the **Processing activities** table, click the **Processing activity details** attribute of the relevant processing activity. The fact sheet is displayed.
7. Select the assets for the following attributes. To do so, click the edit box of the respective attribute, select the relevant name, click  to transfer your input, then click **OK** to confirm your input.
 - a. **Reads:** Data that is read by the processing activity, for example, the customer address.
 - b. **Outputs:** Data that is created by the processing activity, for example, the sales quotation.
 - c. **Controllers:** (Legal) entity that is controller (page 43) of the processing activity, for example, the sales department.
 - d. **Processors:** (Legal) entity that is processor (page 44) of the processing activity, for example, the IT department.
 - e. **IT systems:** Application system on which the processing activity is executed, for example, SAP HR.

The assets are assigned to the processing activity.

10 Describe processing activities for the record of processing activities

The GDPR (page 43) requires a record of processing activities with all processing activities (page 44) of a legal entity including a minimum set of details. The requirements for the record of processing activities can vary from country to country.

For this purpose ARIS Accelerators for GDPR offers the **Record of processing activities (page 32) report**. This report uses information from ARIS object attributes. Additionally, the Survey Management of ARIS Risk & Compliance Manager is used to gather report-specific information for each processing activity. ARIS Risk & Compliance Manager ensures the segregation of duties principle and offers an audit trail of any changes. For detailed information on this report, refer to **Generate required internal and external reports** (page 32).

Use the **Processing Activity Documentation** questionnaire to describe identified processing activities. This questionnaire template is a generic questionnaire template that can be customized.

The regulatory description is created with Survey Management of ARIS Risk & Compliance Manager. For each processing activity, you must perform two steps:

- Create a processing activity description survey (page 17)
- Execute a processing activity description survey (page 19)


10.1 Create a processing activity description survey



Use ARIS Connect to prepare a processing activity description survey.



Prerequisites

- You have the **ARIS Connect Viewer > Contribution** license privilege.
- The relevant objects are available in a **Record of processing activities** model and assigned to the respective legal entity.
- The ARIS GDPR method enhancement filter is imported. For detailed information, refer to the **ARIS Accelerators for GDPR Installation Guide**.
- The questionnaire for describing processing activities (**GDPR Processing Activity Documentation**) is installed and adapted to your specific requirements. The value of the **ARCM Synchronization** attribute at the **Questionnaire template** object must be **true** (default value). For detailed information, refer to the **ARIS Accelerators for GDPR Installation Guide**.

Procedure

1. Start ARIS Connect.
2. Enter the name of the relevant **Record of processing activity** model to the  **Search** field.
3. Click the model containing the relevant processing activity in the list of results. The fact sheet is displayed.

4. Click  **Edit** >  **Contribute** if the edit mode is not activated yet.
5. In the **Processing activities** table, click the **Processing activity details** attribute of the relevant processing activity. The fact sheet is displayed.

The link is only available if the elements are already assigned (page 15) to the processing activity.
6. Click the edit box of the **Questionnaires** attribute to add a new element.
7. Enter a name according to the respective processing activity and the description survey, for example, **Salary payment GDPR description**, click  to transfer your input, then click **OK** to confirm your input. The **Questionnaires** attribute is created.
8. Click the **Questionnaires** attribute. The fact sheet is displayed.
9. Specify the relevant survey details. To do so, click the edit box of the respective attribute, enter the relevant information, click  to transfer your input, and click **OK** to confirm your input (only for some attributes).
 - a. **Responsible**: Any user responsible for this survey.
 - b. **Description*)**: Short description of the survey.
 - c. **Questionnaire templates*)**: The questionnaire template to be used in the survey. Use the **GDPR Processing Activity Documentation (Controller)** or the **GDPR Processing Activity Documentation (Processor)** questionnaire template.

Important: If a different template is used for the **Record of processing activities** report, you must set the attribute value **GDPR-PAD-C** for the **Identifier of the questionnaire template** object for controller entities and **GDPR-PAD-P** for processor entities.

ARIS Accelerators for GDPR uses the Survey Management of ARIS Risk & Compliance Manager to qualify each processing activity. ARIS Risk & Compliance Manager ensures the segregation of duties principle and offers an audit trail of any changes. ARIS Accelerators for GDPR contains a questionnaire (**GDPR Processing Activity Qualification**) for qualifying the processing activities. The template is based on the recommendations of the ARTICLE 29 DATA PROTECTION WORKING PARTY (Guidelines on Data Protection Impact Assessment (DPIA) and determining whether processing is likely to result in a high risk for the purposes of Regulation 2016/679). For each processing activity, the actual score is calculated by adding up the answer values of the selected answers. If the actual score exceeds the target score (default set to 10, equaling two risk aspects), the processing activity concerned can involve a high risk to the data subjects in the sense of GDPR. This template is meant to be an initial questionnaire template that can be customized.

ARIS Accelerators for GDPR contains a questionnaire (**GDPR Data Protection Impact Assessment**) for assessing the processing activities. This template is based on the recommendations of German Bitkom association. For each processing activity, the results of the assessments are commented and a degree of fulfillment is selected. By default there are four degrees of fulfillment: not fulfilled, partly fulfilled, widely fulfilled, and completely fulfilled. If necessary you can enhance them. This template is meant to be an initial questionnaire template that can be customized.

Each degree of fulfillment represents a fulfillment score. This score serves to focus first the less fulfilled aspects of the processing activity. 3. Click the relevant element in the list of results. The fact sheet is displayed.
4. Click **Dashboards**. The relevant dashboard is displayed.
5. Use the filter to obtain a particular view.

16.1 GDPR - Overview

This dashboard serves as an overview of GDPR relevant information of one organizational unit. The respective manager of an organization unit can see the number of processing activities he is responsible for and how many of them were added recently. Additionally, the role of this organizational unit for each processing activity (Controller (page 43) role or Processor (page 44) role) is displayed, as well as an overview of incidents occurred at the processing activities of this organizational unit.

CHARTS

ACTIVITIES RELATED TO THE UNIT

Shows the number of processing activities connected to the selected organizational unit.

Calculation

Counts in the ARIS database the number of processing activities. Only the processing activities connected to the selected organizational unit are included in the calculation.

NEW ACTIVITIES RELATED TO THE UNIT

Shows the number of new processing activities, connected to the selected organizational unit, that were created during the period specified in **Period in days**.

Calculation

Counts in the ARIS database the number of processing activities with creation date during the specified period. Only the processing activities connected to the selected organizational unit are included in the calculation.

ACTIVITIES WITH NEW INCIDENTS

Shows the number of processing activities that are connected to the selected organizational unit, and that are connected to incidents with occurrence date during the period specified in **Period in days**.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of processing activities that are connected to incidents with occurrence date during the specified period. Only the processing activities connected to the selected organizational unit are included in the calculation.

TOTAL GDPR INCIDENTS FOR THE UNIT

Shows the total number of incidents that were created in the context of processing activities connected to the selected organizational unit.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of incidents that are connected to processing activities. Only the processing activities connected to the selected organizational unit are included in the calculation.

NEW ACTIVITIES OVER TIME

Shows the development of the number of processing activities created during the last six months, that are connected to the selected organizational unit.

Calculation

Counts in the ARIS database the number of processing activities with creation date during the last six months. Only the processing activities connected to the selected organizational unit are included in the calculation.

NEW INCIDENTS OVER TIME

Shows the number of incidents of the last six month in the context of processing activities connected to the selected organizational unit.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of incidents with occurrence date during the last six months that are connected to processing activities. Only the processing activities connected to the selected organizational unit are included in the calculation.

ACTIVITY OVERVIEW

Shows a list of processing activities that are connected to the selected organizational unit, and the GDPR (page 43) role connected to each processing activity.

Calculation

Collects in the ARIS database the processing activities of each connection type. Only the processing activities connected to the selected organizational unit are included in the calculation.

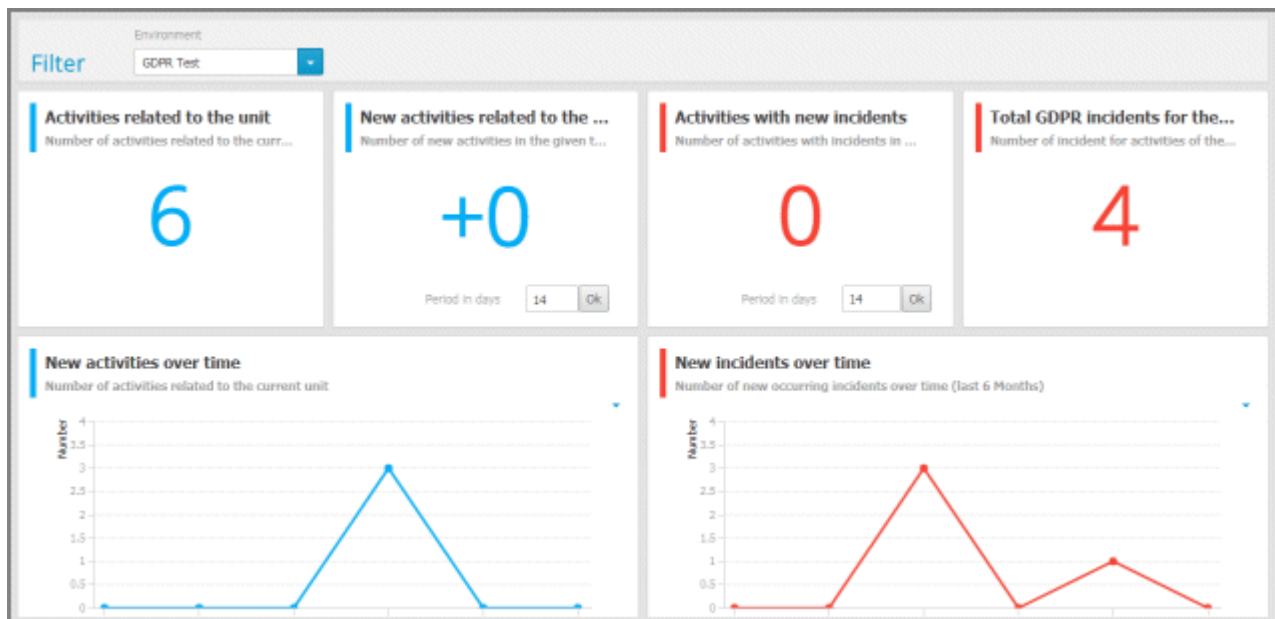
ACTIVITIES WITH NEW INCIDENTS OVER TIME

Shows the number of processing activities that are connected to the selected organizational unit, and that are connected to new incidents occurred during the last six months.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of processing activities that are connected to incidents with occurrence date during the last six months. Only the processing activities connected to the selected organizational unit are included in the calculation.

16.2 GDPR – Workflow

This dashboard shows the main phases of the GDPR workflows of surveys and risk assessments. It gives an overview of the status of the different GDPR project steps.

Shows the distribution of processing activities with and without connection to survey tasks that are connected to the selected questionnaire template.

Calculation

Counts in the ARIS database the number of processing activities that are connected to a survey task that is connected to the selected questionnaire template. Only the processing activities connected to the selected organizational unit are included in the calculation.

SURVEY TASK EXECUTION PROGRESS

Shows the distribution of survey tasks (based on the data of the **Questionnaire assignment progress** chart) with and without generated surveys.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of surveys that were generated with the survey tasks from the **Questionnaire assignment progress** chart. Only the processing activities connected to the selected organizational unit are included in the calculation.

SURVEY STATUS PROGRESS

Shows the distribution of generated surveys with their status based on the data of the **Survey task execution progress** chart.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of surveys in each survey status that were generated with the survey tasks from the **Questionnaire assignment progress** chart. Only the survey tasks connected to processing activities that are connected to the selected organizational unit are included in the calculation.

RISK ASSIGNMENT PROGRESS

Shows the distribution of processing activities with and without connected risks.

Calculation

Counts in ARIS database the number of processing activities that are connected to a risk. Only the processing activities connected to the selected organizational unit are included in the calculation.

RISK ASSESSMENT CREATION PROGRESS

Shows the distribution of risk assessments (generated or not yet generated) based on the data of the **Risk assignment progress** chart.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of processing activities that are connected to risks that are at least connected to one generated risk assessment. Only the processing activities connected to the selected organizational unit are included in the calculation.

RISK ASSESSMENT WORKFLOW PROGRESS

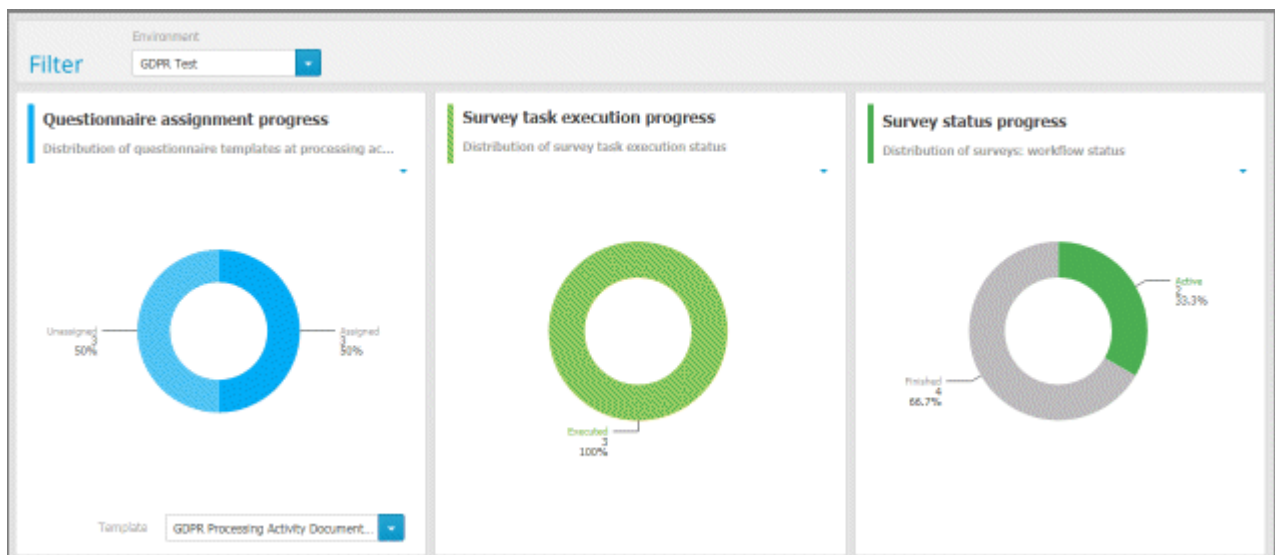
Shows the distribution of risk assessments with their risk owner status based on the data of the **Risk assessment creation progress** chart.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of processing activities that are connected to a risk object. From this quantity, the number of risk assessments with their risk owner status are taken into account. Only the processing activities connected to the selected organizational unit are included in the calculation.

16.3 DPIA - Answers

This dashboard offers analysis capabilities regarding the results of data protection impact assessment workshops. The various areas of such an assessment are shown with their resulting degree of fulfillment. You can display GDPR weaknesses and assessments (with degree of fulfillment less than 100 %) for further analysis or creation of mitigation measures (issues).

AVAILABILITY

The **DPIA - Answers** dashboard is displayed in **Processing activity** fact sheets in ARIS Connect. For detailed information on data sources and calculation of ARIS Aware dashboards, refer to the ARIS Aware online help.

CHARTS

DPIA PROGRESS

Shows the distribution of DPIA elements according to their answer status (answered, not answered). The user can monitor the completion of the data protection impact assessment.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of questions to be evaluated with their degree of fulfillment. Then, they are grouped according to the answer status.

DPIA SUBJECTS BY RESULT

Shows the distribution of DPIA elements to be assessed by the degree of fulfillment. The user can monitor the proportion of aspects with more or less weaknesses.

Calculation

Counts in the ARIS Risk & Compliance Manager database the number of answered questions and groups them according to the degree of fulfillment.

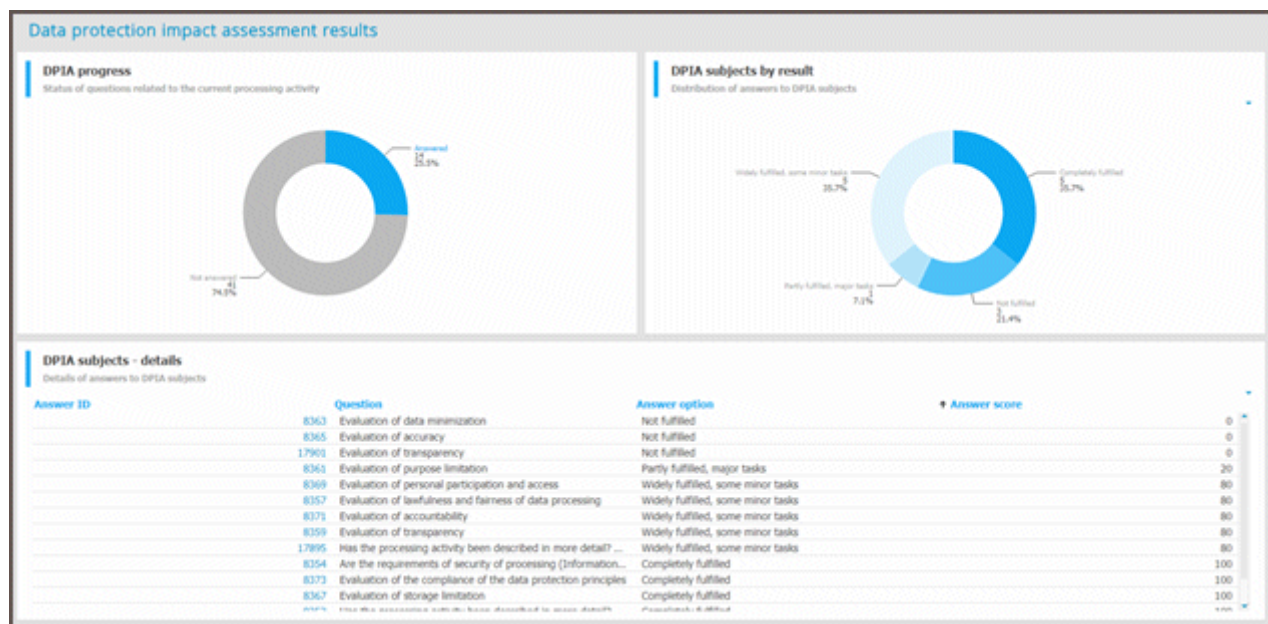
DPIA SUBJECTS - DETAILS

Shows the details of DPIA elements including their degree of fulfillment score. The user can rank the DPIA aspects according to the significance of their weaknesses. A link to the answered question in ARIS Risk & Compliance Manager is available.

Calculation

Lists the answered questions in the ARIS Risk & Compliance Manager database and sorts them along the degree of fulfillment.

16.4 DPIA - Issues

This dashboard serves as an overview of mitigation measures (issues) regarding the weaknesses found during the data protection impact assessment of a processing activity. You can display each issue for further analysis and management.

AVAILABILITY

The **DPIA - Issues** dashboard is displayed in processing activity details fact sheets in ARIS Connect.

CHARTS

NUMBER OF ISSUES

Shows the number of issues related to the current data protection impact assessment.

Calculation

Counts the number of issues in the ARIS Risk & Compliance Manager database that are connected to answered questions of the DPIA questionnaire of the concerned processing activity.

ISSUES PRIORITY DISTRIBUTION

Shows the distribution of issues concerning the DPIA questions according to the issue priority. The user can monitor the proportion of issues with more or less priority.

Calculation

Counts the number of issues in the ARIS Risk & Compliance Manager database that are connected to answered questions of the DPIA questionnaire of the concerned processing activity. Then, they are grouped according to the issue priority.

DETAILED ISSUE DESCRIPTION

Shows the details of DPIA issues. The user can rank the DPIA issues according to their priority. A link to the issue object in ARIS Risk & Compliance Manager is available.

Calculation

Lists the issues assigned to answers of the DPIA questionnaire of the current processing activity in the ARIS Risk & Compliance Manager database and sorts them according to their priority.

17 Glossary

C

Controller

Determines the purpose and means of processing personal data. (Role according to article 4 of the GDPR (page 43).)

D

Dashboard

A dashboard is an interactive application that merges, combines, and clearly visualizes data from different data sources. The data can come from different sources and is combined together. Possible data sources include Excel or CSV files, reports from ERP or CRM systems, requests from data warehouses, or freely available machine-readable data from the Internet. Dashboards are made up of individual graphic components (for example, business graphics, tables, maps, etc.), which obtain their data from data feeds and display it. The individual display components can be linked to one another so that the results displayed can be interactively filtered and therefore intuitively analyzed.

Data protection officer

Informs and advises the controller (page 43)/processor (page 44) of their obligations, monitors compliance, provides advice, and acts as the contact for the supervisory authority.

Data protection representative

Represents the controller (page 43)/processor (page 44) with regard to their respective obligations under GDPR.

G

GDPR

The General Data Protection Regulation (GDPR) protects the rights of individuals' personal data within the European Union. It also regulates the export of personal data outside the EU. GDPR is a regulation by the European Parliament, the Council of the European Union, and the European Commission.

GDPR roles

ROLES ACCORDING TO ARTICLE 4 OF THE EU GDPR (PAGE 43)

- **Controller**
Determines the purpose and means of processing personal data.
- **Processor**
Processes personal data on behalf of the controller.

ROLES IN COMPANIES

- **Data protection officer**
Informs and advises the controller/processor of their obligations, monitors compliance, provides advice and acts as the contact for the supervisory authority.
- **Data protection representative**
Represents the controller/processor with regard to their respective obligations under GDPR.

I

Incident

In the Governance, Risk & Compliance environment an incident is the trigger for a loss.

Issue Management

The Issue Management of ARIS Risk & Compliance Manager enables processes and objects, for example, risks, controls, and policies, to be combined in an issue across different contexts, so that it can refer to different situations or assign tasks.

Unlike deficiencies, issues are one-off problems that occur in the business environment. Issue Management allows you to document, analyze, and monitor identified issues for the purpose of crisis prevention. The goal is to make problematic issues known in time and resolve them.

P

Processing activity

A processing activity is any operation which is performed on individuals' personal data, such as collection, recording, disclosure by transmission, and therefore is subject to the General Data Protection Regulation (GDPR (page 43)).

Processing activities and associated information are modeled in **Processing activity description diagram** models and **Record of processing activities** models in ARIS Architect. For detailed information, refer to the **ARIS Risk & Compliance Manager - Data Protection Management** guide.

Processor

Processes personal data on behalf of the controller (page 43). (Role according to article 4 of the GDPR (page 43).)

S

Single sign-on (SSO)

With **SSO** or **single sign-on** the user only needs to authenticate himself once with his user name and password to access all services, programs and computers without logging in again.

If services, programs, and computers request a new authentication when accessed by the user the authentication is carried out by the underlying SSO mechanism.

T

Tenant

A tenant is a container providing its own ARIS Administration and ARIS data set, such as configuration, ARIS method, databases, scripts, etc.

Each tenant provides users with a particular set of functionalities and specific data depending on their licenses and privileges.

18 Disclaimer

ARIS products are intended and developed for use by persons. Automated processes, such as the generation of content and the import of objects/artifacts via interfaces, can lead to an outsized amount of data, and their execution may exceed processing capacities and physical limits. For example, processing capacities are exceeded if models and diagrams transcend the size of the modeling area or an extremely high number of processing operations is started simultaneously. Physical limits may be exceeded if the memory available is not sufficient for the execution of operations or the storage of data.

Proper operation of ARIS products requires the availability of a reliable and fast network connection. Networks with insufficient response time will reduce system performance and may cause timeouts.

If ARIS products are used in a virtual environment, sufficient resources must be available there in order to avoid the risk of overbooking.

The system was tested using scenarios that included 100,000 groups (folders), 100,000 users, and 1,000,000 modeling artifacts. It supports a modeling area of 25 square meters.

If projects or repositories are larger than the maximum size allowed, a powerful functionality is available to break them down into smaller, more manageable parts.

Some restrictions may apply when working with process administration, ARIS Administration, ARIS document storage, and ARIS Process Board, and when generating executable processes. Process Governance has been tested and approved for 1000 parallel process instances. However, the number may vary depending on process complexity, for example, if custom reports are integrated.

ARIS document storage was tested with 40.000 documents. We recommend monitoring the number and overall size of stored documents and archiving some documents if needed.
