- DBU-438
 - Searching for logged fields of type "float" in a DBO process instance will not return correct values when using the equals operator.
 - When constructing a search of logged fields of type "float" in a DBO process instance, using the equals operator will not return correct results in Business Console for DBO processes.

 Workaround: When searching for logged fields of type float, supported comparisons are
 - Workaround: When searching for logged fields of type float, supported comparisons are greater than (">") and less than ("<").
- DBU-482
 - DBO actions like play and restart involve encoding and decoding of the process pipeline. In the event, numeric fields in the pipeline with datatypes like integer and float may get altered to long and double respectively. This may cause issues with the evaluation of conditions in the decision table that use those fields when a restart or play action is involved.
 - There is no workaround for this issue.
- DBU-519
 - An incorrect status is displayed for a user task step in a loop where one of the loop iterations fails.
 - When a process containing a user task contained in a loop fails in one of the loop iterations, the step is incorrectly shown as running rather than failed.
 - There is no workaround for this issue.

pub.monitor.archive:processArchive does not archive DBO instances in addition to PE instances. In order to archive DBO instances, two new parameters are added to Operation parameters table, DBO_PROCESS_STATUS_CRITERIA and DBO_PROCESSES. To archive DBO processes set

DBO_PROCESSES to true. By default DBO_PROCESS_STATUS_CRITERIA are set to archive instances with status Completed, Canceled and Terminated. These parameters can be set using the pub.monitor.archive:setOperationParameters service.

5.0 Other Resolved Issues

• DBO-113

Configuring an IS cluster results in an exception on the WmDBO home page. After installing and starting an Integration Server instance where DBO is installed, configuring an IS cluster will result in the exception "could not initialize cache manager SoftwareAG.IS.DBO" on the WmDBO home page. This issue is resolved.

DBO-124

DBO process containing step with inline document cannot be saved. A DBO process that uses IS services with Document or Document list in the service signature of a step will result in process not able to upload or execute exception when saving in Designer. This issue is resolved.

DBU-523

Stage is incorrectly shown as completed when hitting the breakpoint of an End Milestone step. An "End Milestone" for a stage on a step that has breakpoint will incorrectly show the stage as

completed when the breakpoint hits.

This issue is resolved.

WMDPD-9337

DBO models fail deployment

If a DBO model is deployed using Deployer ACDL, a class loading failure may be observed. This issue is resolved.

WMDPD-8889

No visual cue is provided for setting input or output mapping for a step with Dynamic processes.

When setting the pipeline mapping for Dynamic processes, the Pipeline view displays map elements for that step depending upon the area of the step selected. The step type that supports mapping now has a left "side" and a right "side", such that when you select the left side of the step its input mapping is shown in the Pipeline view, and when you select the right side of the step its output mapping is shown in the Pipeline view. However, there is no visual cue that indicates input our output mapping is being selected.

This issue is resolved.

DBU-241

Step Summary panel may display incorrect entries for subprocesses and steps. Executing a DBO process containing a subprocess with looping and nested subprocess with looping will display incorrect entries for the looped instances in the Step Summary panel. This issue is resolved.

DBU-343

Status of task step execution in a loop displays all task steps with status of the last task step executed.

When a DBO process with a task step contained in a loop is executed, the status of all the task steps is displayed as the status of the last iteration of the task step in the loop in the Step Summary panel.

This issue is resolved.

• DBU-336

Instances of task steps executed in a loop contain the same task ID in Step Summary table. If a DBO process with a task step contained in a loop is executed with multiple instances, each instance will contain the same task ID when displayed in the Step Summary panel. This issue is resolved.
