- WOK-8197
Cancel button does not cancel all changes and may cause an exception on Internet Explorer 11. On Internet Explorer 11, the cancel button in the decision entity editor will not cancel all edits if only an operator and no value were selected as cell content. Upon closing and re-opening the decision table, an exception may occur.
There is currently no workaround for this issue.
- WOK-8110
Show hidden warnings link causes an exception if no decision entity is selected. If no decision entity is selected in the Rules Management Console, clicking on the Show hidden warnings link in the Rule Project Verification window causes a NullPointerException.
As a workaround, select a decision table or event rule before clicking the link.

3.0 Usage Notes

This section provides additional information you need to work with the current release of webMethods Rules Management Console.

- If the My webMethods Server is installed on Linux, it may be necessary to explicitly specify the host name in the server configuration, otherwise the export of rule projects from Software AG Designer may not work. `<Software AG installation directory>/MWS/server/<server name>/bin/server.properties.sh` should contain the following line:
`RMI_HOSTNAME =<fully qualified server domain name or IP address >, e.g.
RMI_HOSTNAME=mws.example.com.`
`<Software AG installation directory>/MWS/server/<server name>/config/wrapper.conf.template` should contain the following line:
`set.RMI_HOSTNAME=<fully qualified server domain name or IP address >, e.g.
set.RMI_HOSTNAME=mws.example.com.`
- After installing or updating the Rules Management Console, it is necessary to click the Update Entries in Navigation Pane button on the Welcome page. This will synchronize the rule projects displayed in the navigation pane with the My webMethods Server repository. It may also be

necessary to refresh the navigation pane.
